CEDC Receives "Affordable Builder of the Year" Award

Affordable Homes Can Be Green

Karen Flock, CEDC's Director of Real Estate Development, accepted the "Affordable Builder of the Year" award from Build it Green (www.builditgreen.org), a membership-supported Bay Area nonprofit organization that works with building and real estate professionals, local and state governments, and homeowners to increase awareness and adoption of green building practices. Karen attended a special ceremony to receive the award on December 6 in Oakland.

CEDC submitted four multifamily projects, 169 homes, for the Green Point Rated certification this year. The highest scoring property received 198 points on the Green Point Rated scale. This was the second highest score of all new multifamily projects submitted for the Green Point Rated certification in California in 2012.

CEDC looks forward to more "green" achievements in the coming years.

Azahar Place, located at 11370 Mimosa Street in east Ventura, is the first LEED for HOMES certified development in the City of Ventura. This 60-apartment complex for low-income families, some of which are designated for farmworkers, was completed in June by CEDC. A grand opening celebration took take place at the property on Friday, November 30.

Perhaps the greatest attainment by CEDC for this community is having successfully reached the LEED® for Homes Platinum level of certification established by the U.S. Green Building Council (USGBC) for achievement in green home building and design. LEED, which stands for Leadership in Energy and Environmental Design, is a green home certification program that rewards homes that are designed and built to be energy- and resource-efficient, and more healthy and durable for the occupants. LEED-certified homes complete a technically rigorous process that often includes a home energy (HERS) rating and onsite inspections to verify that the home is built to be energy and water efficient, environmentally sound, and a healthier place to live.

"As a LEED-certified development, Azahar Place serves as a model of greener living for the entire community," said Nate Kredich, Vice President of Residential Market Development for the USGBC. "Azahar Place sets the example that we can all live better by reducing our environmental footprint, cutting our utility bills, and coming home to a greener place to live."

CEDC made a special presentation to Ellen Brokaw (see photo above, lower right), a long-time advocate with her husband Hank, of farmworkers in Ventura County. The community room at Azahar Place has been named the "Ellen and Hank Brokaw Community Room" for the couple's tremendous work in social and housing justice for farmworkers.

Yale Street Apartments Get a Makeover!

CEDC's expert construction team just completed the rehabilitation of our Yale Street community in Santa Paula. All 26 apartment homes at the property, located at 739 Yale Street, underwent work including structural repairs, demolition of an unused building, new flooring, new cabinets and counter tops, paint inside and out, landscaping, a new block wall and a new parking lot. CEDC spent nearly \$500,000 in contracts and materials on the rehabilitation project, mostly working with local contractors and suppliers.

Everyone who had to move during construction was able to move back into their home for the holidays.

Yale Street is one of six communities in Santa Paula owned and managed by CEDC.

CASH Program graduates toast their success

The CEDC NeighborWorks HomeOwnership Center congratulates the first graduating class of the CASH Financial Coaching Program! The "Creating A Stable Home" program is a financial coaching program for adult residents of Ventura and Santa Barbara Counties interested in learning to save money for a successful future. We applaud the 16 individuals who completed the program for their hard work and perseverance throughout the 12 months of coaching sessions and Financial Empowerment workshops they attended.

Of the individuals or families who graduated from the program:

- 100% saved a minimum of \$300 (a program requirement)
- 81% increased one or more of the FICO scores (average increase per household was 25 points, with the highest FICO jump being 118 points)
- 69% reduced their debt (for a combined total of \$24,162)
- 38% saved an additional \$13,635 (Combined savings of the group was \$19,435)
- 25% say they are now ready and/or will be ready for homeownership in the next six months.

Lorrie Brown is one of the recent graduates of the CASH Program. Here, Lorrie

was sharing how the CASH Financial Coaching Program helped her make healthy financial decisions allowing her to save toward the down payment for her future home. She said: "Even though I may not have had a lot of money, I did learn: to spend frugally, to put a little away every month, and there is nothing to be afraid of because I am worth it."

Two of the CASH program participants even participated in the Women's Economic Ventures

Independent Foreclosure Review



Distressed homeowners

There's good news for homeowners who have gone through the foreclosure process. According to the Cabrillo Economic Development Corporation, they now have until December 31 to request a free review and could receive compensation if errors are found.

Ordered by federal bank regulators--the Office of the Comptroller of the Currency and the Board of Governors of the Federal Reserve System--independent consultants will review foreclosure actions to determine whether borrowers suffered financial injury as a result of foreclosure errors. Where financial injury is found, regulators have directed mortgage servicers provide compensation or other remedy. Regulators are overseeing the reviews and will approve plans to compensate affected homeowners.

CEDC is helping homeowners in Ventura County learn if they may be eligible for a FREE independent review of their foreclosure and will direct


